The Law of the Manor is the definitive work on the subject, providing detailed, up-to-date and comprehensive coverage for lawyers and also to those owning, managing, selling or buying historic houses and estates. It provides a modern description of the law associated with lord-ships of the manor. Principally concerned with the lands and rights of the lord, the book also considers rights that tenants of the manor can claim against him. These are put in context with a discussion of associated topics such as franchises and titles of nobility.

The second edition has been updated to cover numerous developments in the law since 1998, in particular the Land Registration Act 2002, the Countryside and Rights of Way Act 2000 and the Commons Act 2006. The book includes changes made by the Hunting Act 2004, the House of Lords Act 1999, and the Legal Services Act 2007 as well as the relevant case law. New material has been included on escheat, rectorial manors and roadside verges. There is also greater coverage of legal authorities especially in the eighteenth and nineteenth centuries and a selection of useful precedents for the practitioner. Although the book is about the law of the manor in England and Wales, there is some reference to other jurisdictions, most notably the experimental extension of the manorial system to some American colonies.

The text is arranged in five parts. Part 1 describes the context, summarises the history and analyses custom which is the basis of manorial law. Part 2 describes the lands of tenants and lords and the relations between them. Part 3 discusses rights and comprises a detailed commentary on section 62(3) of the Law of Property Act 1925. It covers rights of common, mineral and sporting rights, courts and remaining revenues. Part 4 sets the manor in the context of other institutions, namely the village, the church, towns and feudal relationships. Part 5 summarises and looks at the modern manor, its documents, conveyancing (with particular reference to registered land) and taxation, concluding with suggestions for reform.





The Wallace Case is one of the most notorious murder cases of all time. The issue of whether Wallace was guilty or innocent of his wife's brutal murder has been the subject of conjecture among lawyers, criminologists and writers for years. Eighty years on, the case remains unsolved. For several commentators the murder of Julia Wallace was the 'perfect murder'.

William Wallace was a mild-mannered insurance agent, who lived in apparent harmony with his wife, Julia. One evening he attended his chess club to be informed of a telephone message requiring him to visit the caller the next day on a matter of insurance business. Wallace knew neither the address nor the name which the caller had given, but set out, the following day, to keep the appointment. After a long and fruitless search for the house, during which he enquired of nine people, two of whom told him that there was no such address, Wallace returned home to find his wife had been brutally murdered by a series of violent blows to the head from an instrument that was never found. Exhaustive police enquiries drew a complete blank. Detectives came to the view that Wallace himself had made the phone call, using a disguised voice. The phone call, they believed, had been used to create an alibi for the murder which he had committed before he left home. Despite his protestations of innocence, Wallace was duly arrested and charged with the murder of his wife.

At the trial, notwithstanding a favourable summing up by the judge, the jury found Wallace guilty. However on his appeal the Court of Criminal Appeal reversed the guilty verdict and the case against him was dismissed. Wallace subsequently wrote about this ordeal, naming for the first time, another suspect. He died in 1953 and was buried next to his deceased wife.

In The Telephone Murder Ronald Bartle brings alive this dramatic and challenging case, whilst carefully considering the points both assisting the prosecution and those in favour of the defence




In comparative legal studies, the concept of legal culture has come to play an increasingly significant role in contemporary theorising, empirical analysis and methodological innovation. This book, entitled Using Legal Culture, explores a number of the key issues regarding the use of this concept.

What do Prince Charles, Bette Davis, Sir Ian Botham, Mrs Victoria Gillick and a man whose family grave appeared in the background of a splatter horror film have in common? Each of them felt they had been wronged in some way, and each went to court to try and do something about it. Sometimes their case was a purely private argument. Others brought cases of national importance, or claims which raised acute moral and ethical principles. Some won handsomely, while others lost so badly that they ended up far worse than when they started. This new book looks at fifty legal disputes from Victorian times to the present day, where a compelling moral or legal issue was at stake, or where the background to the case was interesting, amusing or infuriating. It begins with three Victorian murders, including the law student favourite of R v Dudley and Stephens, the case of shipwrecked sailors eating the cabin boy and later facing trial for his murder.
